

What is Title I

Title I is a K-12 program that provides additional academic support and learning opportunities for students at schools with high percentages of socioeconomically disadvantaged children. The program is intended to help ensure that all students meet state academic standards.




Goals of Title I


- Increase academic achievement



Parent Involvement






At Ira Harbison we have a very strong PTA. This is a great way to get involved.



School Achievement Data


- Ira Harbison will be analyzing Smarter Balance and The English Language Proficiency Assessments for California (ELPAC).

Single Plan for Students Achievement





- Parents are informed about the school's curriculum in English/ Language Arts and Math, as well as other core subjects.



Ira Harbison Technology Vision Statement



- At Ira Harbison the use of technology in instruction changes the structure of the classroom. No longer will the teacher rely solely on the traditional lecture/seat work method of instruction.
- Ira Harbison has technology-rich, learner-centered classrooms, where the teacher serves as a facilitator of instruction, mentor, and coach.
- At Ira Harbison technology helps to provide a record of the student's academic history and serves as a way to manage learning progress and activities.
- At Ira Harbison teachers have the data and information needed to individualize instruction and assessment as well as make other important instructional management decisions.
- Through the use of technology at Ira Harbison, teachers and students access a wealth of materials, services, and networks throughout the state, nation, and world.





At Ira Harbison technology does not replace the teacher, but rather supports and enhances the educational process.



Title I Funds

[Federal Funds]

- Allocated on basis of number of students eligible for free/reduced lunch. Schools receive Title I funds if 40% or more of students are eligible for free/reduced lunch.
- Schools in NSD are ranked according to this percentage, and schools receive a certain amount of money per student.




Title I Funds (cont.)

- One percent of a school's total Title I budget is for parent involvement activities.
- Schools in Program Improvement must set aside a minimum of 10% for professional development.
- Funds must supplement, not supplant district funds.





The Title I Parent Involvement Policy

Every Title I school, in collaboration with parents, must prepare a site level parent involvement policy which describes how the school will involve the parents in an organized, ongoing, and timely way in the planning, review, and improvement of the Title I program at the school.



The Home/School Compact describes the responsibilities of the school, the parent, and the student for improved student achievement.





Home/School Compact
