Trustees reviewed a report submitted by the San Diego County Superintendent of Schools, Paul Gothold, Ed.D., presenting aggregate findings as required by the William's Settlement Legislation for National School District's 2021-2022 school visits.

Integrity Charter School presented an annual report for the 2020-2021 school year academic achievement and goals for the 2021-2022 school year. Included was the school's performance on multiple assessments; including data on English learners, students with disabilities, ethnicity and how those groups have done over time at Integrity.
